Nebraska			Fingerprints are requested from the "victim" and compared with the suspect with the criminal record. If determined not to be the same, the "victim" prints are left in the suspect's record with notations that it's not the same person. All the identifiers are corrected at the state repository and then also forwarded on to the FBI for correction.

Nevada			The NV Attorney General's Office handles criminal identity theft issues, not the State Repository. The process begins when the victim files a police report with a local law enforcement agency, who in turn gives the victim a brochure which explains the NV AG's Identity Theft Program and contains an application for an Identity Theft Program Card. The victim must then schedule an appointment with the staff of the NV AG's Office to review his/her identity theft program application. Victims are asked to provide at least two forms of identification, a photo, signature, and a thumbprint as part of the application process. This identification procedure is to protect against a person obtaining an ID Theft Program Card under false pretenses. If the application is approved, the victim will receive an ID Theft Program Card which displays the person's photo, signature, and thumbprint and can be used to alert law enforcement and creditors that the person's identity has been stolen.

New Jersey			Victim must appeal to the law enforcement agency that submitted the errant information. SBI will amend CHRI only at the request of the submitting arresting agency. Victims may also afford themselves the use of the NCIC Identity Theft File.

Upon receipt by the AG of a certified copy of the court order and upon request by such person, the Office of the AG, on cooperation with the State Police, shall issue an "Identity Theft Passport" stating that such an order has been submitted. The office of the AG shall provide access to identity theft information to (i) criminal justice agencies and (ii) individuals who have submitted a court order pursuant to this section. When the Office of the AG issues an Identity Theft Passport, it shall transmit a record of the issuance of the passport to the DMV. The Department shall note on the individual's driver abstract that a court order was obtained pursuant to §19.2-392.2 and that an Identity Theft Passport has been issued.

If the Nevada AG's Office approves an identity theft application, they input the victim's information and a unique password of the victim's choosing into the Identity Theft file in the state criminal justice information system. If the victim has an encounter with law enforcement, the officer will run the victim's name through the state system and ask the victim to verify his ID theft password. If the password that the victim gives matches what is in the system, then the officer knows that the individual is who he claims to be.
